Pursuant to written notice, the regular meeting of the City of Northfield Council was held on Monday, March 26, 2018, at the Fenley Office Park, 4965 U.S. Highway 42. The meeting was called to order at 7:30 p.m., by Mayor Chappell.

MINUTES

Minutes of the February 26, 2018, meeting were approved as distributed.

TREASURER'S REPORT

Council members reviewed the Income Statement for the General Fund for the month ending February 28, 2018, the Balance Sheet and the City's List of Investments for the General Fund as of February 28, 2018. They also reviewed the Income Statement and the Balance Sheet for the Road Fund for the month ending February 28, 2018, the General Ledger and the Check Register from February 1 through February 28, 2018.

CLERK'S REPORT

POLICE REPORT

Police Chief Richard Frank briefed council members on recent activities throughout the city including a break-in in the 2400 block of Glenview Avenue. Three citations were issued this month.

OLD BUSINESS

PROPOSED VA MEDICAL CENTER

Pat Roles, a Northfield representative to the Coalition of Concerned Veterans, Citizens and Cities, discussed the lawsuit filed by the City of Crossgate against the U.S. Department of Veterans Affairs. She said that most of the surrounding cities were not supporting this lawsuit and recommended that Northfield not support this effort.

CHARTER COMMUNICATIONS

Mayor Chappell and City Attorney Singler reviewed the Right of Way Usage and Franchise Agreement with Charter Communications. Following discussion, it was moved by Mr. Levy and seconded by Mr. Birch that Municipal Order #01, Series 2018, approving a right of way usage franchise agreement relating to communications services, be approved. Council members voting to approve this municipal order: Birch, Levy, Rhea, Smith and Walker. Motion carried.

NEW BUSINESS SPEED HUMPS

At the request of a Northfield resident, speed humps were discussed. Alternatives would be a "slow down" sign or additional "Stop" signs. Council members will review and discuss at the April meeting Northfield's Speed Hump Policy which was proposed in 2010 but not adopted at that time.
