Pursuant to written notice, the regular meeting of the City of Northfield Council was held on Monday, February 24, 2020, at the Fenley Office Park, 4965 U.S. Highway 42. Council Members present; Sharon Berger, Alan Birch, Steve Levy, Clark Rhea and Brandon Smith. Council Member absent: Tracy Walker. City officials present; Mayor Randolph Chappell, Police Chief Richard Frank, Treasurer Charles Veeneman and City Clerk Phyllis Onachilla.
