

**MINUTES OF THE REGULAR MEETING
of the
City of Northfield Council
April 26, 2021**

In keeping with the Coronavirus safety procedures, the regular meeting of the City of Northfield Council was held on Monday April 26, 2021, using the Zoom Meeting computer program. Council members attending: Sharon Berger, Tim Martin, Clark Rhea and Brandon Smith. Council members absent: Steve Levy and Tracy Walker. City officials present: Mayor Randolph Chappell, Police Chief Richard Frank, Treasurer Charles Veeneman, City Engineer Adrian Oliver and City Clerk Phyllis Onachilla. Guest: Mark Snyder with PNC Investments.

The meeting was called to order at 7:30 p.m., by Mayor Chappell.

MINUTES

Minutes of the March 22, 2021, meeting were approved as distributed.

KLC INVESTMENT PROGRAM

Mr. Snyder, with PNC Investments, is the investment advisor for the Kentucky League of Cities' Investment Program. He gave an overview of this program which allows cities to diversify investments in order to increase revenue. He outlined several funds that would be available for investment. The City of Northfield has adopted an ordinance approving participation in investment and financial policies such as this.

TREASURER'S REPORT

Council members reviewed the Income Statement, the Balance Sheet and the City's List of Investments for the General Fund as of March 31, 2021. They also reviewed the Income Statement and the Balance Sheet for the Road Fund for the month ending March 31, 2021, and the General Ledger and Check Register for the period from March 1 to March 31, 2021.

CLERK'S REPORT

POLICE REPORT

Police Chief Richard Frank briefed council members on recent activities throughout the city including shoplifting at CVS. No citations were issued this month.

OLD BUSINESS

GOLF CART ORDINANCE NO. 21-01

Mr. Smith presented City of Northfield Ordinance No. 21-01 Allowing Low Speed Vehicle Travel and Establishing Rules and Regulations for Golf Carts Use on Public Streets. This Ordinance had a first reading. It was moved by Ms. Berger and seconded by Mr. Martin that the City of Northfield adopt this Ordinance. Council Members voting in favor of this motion: Berger, Martin, Rhea and Smith. Motion carried.
